



VOTERS RIGHTS
ARE NOTED

Voters! Potential Registrants! Beware of your rights and privileges in this regard, United Voters Service has representatives in the field who are checking on voter registration in San Diego County.

Numerous reports have come in from all areas concerning "arm-twisting" and influencing of potential voters as to party affiliation as well as reports of downright refusal by a Registrar to register someone who was not of his or her party.

his or her party.

Remember, there is no such thing as a Republican Registrar of Voters or a Democratic Registrar of Voters, All Deputies MUST be non-partisan in the process of taking affidavits of registration.

Here are the rules: A Deputy Registrar of Voters is an employee of the County of San Diego. In the process of taking affidavits of registration he must:

1) not enter into any political discussions

2) not seek to INFLUENCE the choice of the voter as to his political affiliation

register all qualified voters who seek to be registered.

Failure to observe these rules constitutes grounds for immediate dismissal.

Remember, if is your duty as a citizen to report any irregularities. Should any of the above occur, ask to see the identification card of the Deputy Registrar and report the incident to the County Operations Center, Registrar of Voters Office, 287-9400.



Mrs. Hinkle and Mrs. Bratt came to have lunch before they left on their vacations this week.




